Bids shall be evaluated and adjudicated in accordance with the Fetakgomo Tubatse Municipality's Supply Chain Management Policy, Revised Preferential Procurement Regulations of 2017 and responsiveness to the bid documents, 80 points will be for price and 20 points will be for B-BBEE Level Contribution. Bidders must obtain a minimum score required for functionality (70%) to qualify for further evaluation.

## CONDITIONS OF THE BID

1. Bid documents will be on sale for a non-refundable fee of **R500.00**, at the Cashier's Office, Fetakgomo Tubatse Municipality, Lower Ground, 1<sup>st</sup> Kastania Street, Burgersfort, from 08H30 to 15H00 during week-days or can be **downloaded for free from the e-tender portal**.
2. **No briefing session will be conducted due to Covid-19 regulations and health protocol**

All bids will be closed and opened in public on the date of closing at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the Fetakgomo Tubatse Municipality, 1<sup>st</sup> Kastania Street, **Burgersfort**. No late, faxed submission of bids will be considered.
4. The bidders must submit both manual and electronic tender document in the form of CD or USB for consideration.
5. The municipality has no obligation to appoint any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
